You can use this form to apply for a Citizen Service Number (BSN) for yourself, your partner, or your child. Question 1 lists the situations when you can use this form to apply for a BSN.

- We only accept attachments in Dutch, English, or German. If you have an attachment in another language, you need to get it translated yourself.
- Write your initials and surname on each attachment. Put the attachments in an envelope with the form. Do not use staples or paperclips.
- We will only process your application if you include all the required attachments. If you cannot include something, call the Tax Information Line for Non-resident Tax Issues at +31 555 385 385.

  - cohabitation agreement drafted by a notary
  - in the case of a joint child: an extract from the birth register or a deed of acknowledgment
